**Research** -- In 2011 the Association continued efforts to advance its new research-focused strategy and transform the CFS research landscape. A 12-member Scientific Advisory Committee was formed with experts representing a variety of scientific and strategic disciplines to guide and shape the Association's research program. A rigorous review process was developed to evaluate 26 proposals received in response to a Request for Applications that emphasized diagnostic markers and treatments. New policies require investigators to share data and intellectual property. Collaborations with NIH and other institutions will establish a data-sharing platform so funded projects are fully integrated from the start. Association Scientific Director, Suzanne Vernon, PhD, worked closely with grantees approved for funding in 2008 to ensure projects yielded results. Projects are now complete and \$647,940 in seed funding and close collaboration yielded nearly \$5 million in new government awards for CFS research; The Association's patient registry and BioBank for clinical data and samples increased to 449 active participants by year-end. BioBank participants contribute to multiple studies and form the basis of study by various investigators focusing on different aspects of CFS, creating a "research institute without walls" in which the Association is a partner in the design and conduct of research studies. The first collaborative study using BioBank resources was completed with the data being prepared for publication.

**Communications** -- The CFIDS Association offered information and resources on CFS to patients, family members, media professionals, the general public and health care professionals. 2011 activities included: launch of a new website, Research1st.com, which is a one-stop shop for the most current and reliable information about CFS research being conducted by top-flight scientists worldwide. Sections provide information on current research, research findings from completed studies and media coverage as well as a moderated blog at which comments by medical professionals, researchers and members of the CFS community are welcomed. The President & CEO, Scientific Director and members of the Board of Directors participated in over 30 scientific conferences, meetings of federal agencies and media interviews. A monthly e-newsletter was distributed to 8,800 members with the latest information on CFS education, research studies, public policy updates and Association news; A Facebook page was maintained with 6,900 fans, posting relevant information on CFS-specific topics as well as general interest items. Approximately 5,500 individuals received print copies of the Association's publication "SolveCFS the Chronicle of the CFIDS Association of America." Electronic copies were also posted online for wider distribution; An Annual Report was published highlighting events and milestones of 2010.
